**Accreditation rules of the International Ski Federation (FIS) and Organizing Committee (OC) of the 2023/2024 Season 3TRE Madonna di Campiglio Audi FIS Ski World Cup Night Slalom of December 22<sup>nd</sup>, 2023.**

The undersigned accepts the FIS and OC regulations. Particularly he/she confirms and accepts that:

1. He/she is not under a sanction of ineligibility issued by FIS or by an entity the decisions of which are to be recognized by FIS in accordance with the FIS Rules and in particular the FIS Anti-Doping Rules, as no valid accreditation can be issued in such case, respectively, any accreditation already granted at the time such sanction becomes effective will automatically become void.
2. He/she may be responsible for any damage or injury which is caused to third parties. In this respect, he/she understands that, unless he/she is covered by the general civil liability insurance of the OC as a result of his/her specific function either within the Organizing Committee or in application of the ICR, he/she is obliged to have an appropriate civil liability insurance of his/her own.
3. He/she acknowledges and accepts the provisions of the media accreditation regulations, as well as the FIS and 3Tre Covid-19 regulations and protocols.
4. Infront holds the world-wide TV, radio, Internet and multimedia rights to this event. Television and radio networks, production and Internet companies are requested to send their request also to Infront Italy for the approval of their accreditation. TV-cameras can be used only in purpose to their accredited activities. Every camera will be checked and authorized by Infront and must be signed with the official mark from the organizer and/or Infront.
5. The access to the areas subject to strict restrictions (e.g. slope) may be authorized only by the FIS Chief Race Director. Access to these areas is at own risk and responsibility. In this respect, he/she declares to fully release the FIS, the OC and their respective officers, employees and agents, as well as racers, trainers and other participants from any liability in case of any injury or damages he/she or third parties would suffer due to his/her presence in such areas, within the limits of applicable law.
6. The accreditation is personal and not transferable and is valid exclusively for the function specified in the accreditation request and may not be used for other purposes. He/she undertakes to behave properly at all times and to abstain from any act or behavior which interferes with the proper organization of the event including without limitation to use its credential for purposes which are in conflict with legitimate activities authorized by FIS and/or the OC or Infront (e.g., unauthorized commercial or media activities).
7. It is required that the credential must be worn visible and shown to the security staff whenever asked. He/she will strictly comply with the International Competition Rules (ICR) and their by-laws and will strictly follow all instructions of the organizer, the competition jury, the race directors and other representatives of FIS.
8. Any violation of these regulations leads to the immediate invalidation of the credential.
